

Virginia Medicaid for Individuals with Disabilities or Over Age 65



Who Is Eligible?

- ✓ Virginia residents aged 65 or older or disabled
- ✓ Meets income and resource requirements. (*Income includes money earned from jobs, Social Security income, Veterans benefits, pensions, or annuities. Resources are things like checking/savings accounts, stocks, bonds, life insurance, or retirement funds.*)
- ✓ Is a U.S. citizen or has an eligible immigration status

Covered Benefits: Medicaid will pay your Medicare premiums, coinsurance and deductibles.		
Special Low-Income Medicare Beneficiary (SLMB)

2	\$2,135	\$14,470
Covered Benefits: Medicaid will <u>only</u> pay your Medicare Part B premiums.		
Qualified Individual (QI)		
Household Size	Income Limit (135% FPL)	Resource Limit
1	\$1,781	\$9,660
2	\$2,400	\$14,470
Covered Benefits: Medicaid will <u>only</u> pay your Medicare Part B premiums.		
Qualified Disabled and Working Individuals (QWDI)		
<i>Individuals must have lost Social Security disability benefits and Medicare Part A due to work activity to be eligible for QWDI.</i>		
Household Size	Income Limit (200% FPL)	Resource Limit
1	\$2,629	\$4,000
2	\$3,545	\$6,000
Covered Benefits: Medicaid will <u>only</u> pay your monthly Medicare Part A premiums.		

Income limits include the FPL amount plus a standard \$20 unearned income disregard.

Additional income and resource disregards may apply based upon an applicant's income and resource types.
